

## USER'S TERMS & CONDITIONS FOR THE MICHELIN REVIEW AND WIN CONTEST

### 1. **Definitions.**

“**Contest**” means the MICHELIN REVIEW AND WIN CONTEST

“**MICHELIN**” means MICHELIN ASIA (SINGAPORE) CO. PTE LTD

“**Organizer**” means CHIN SENG HIN PTE LTD

“**Contest Period**” means the period from 1<sup>st</sup> February 2021 – 30<sup>th</sup> April 2021.

“**Dealers**” means any MICHELIN authorised dealers

“**Users**” means customers who are the end users of MICHELIN Primacy 4 or MICHELIN Pilot Sport 4 tyres; and purchased them from authorised dealers

2. **The Contest.** Contest participants stand to win 1 set of MICHELIN Primacy 4 tyres if their review of either MICHELIN Primacy 4 or MICHELIN Pilot Sport 4 submitted on [www.sgcarmart.com](http://www.sgcarmart.com) is selected.

**Eligibility.** The Contest is open to all customers whom purchased MICHELIN Primacy 4 or MICHELIN Pilot Sport 4 tyres from authorised dealers. The Prize Winner would be asked to present the invoice for verification by the Organizer.

### 3. **Contest Specifics.**

#### **Customer Contest**

(a) Customers are eligible to enter the Contest when they purchase two (2) to four (4) units of MICHELIN Primacy 4 or MICHELIN Pilot Sport 4 from authorised dealers prior to/ within the Contest Period.

(b) **What to submit.** Customers are required to answer the questions listed on the product review form provided by SGCarmart.

(c) **How to submit.**

1) Scan the QR code found on the promotional material.

i. Fill up the product review form (indicating either Primacy 4 or Pilot Sport 4)

ii. Click Send.

2) Click on the Online Banners uploaded on SGCarmart website.

i. Fill up the product review form (indicating either Primacy 4 or Pilot Sport 4)

ii. Click Send.

(d) **How many Contest Prizes.** Organizer will select **1 winner out** of all eligible submissions

(e) **What are the Contest Prizes.** The Prize Winner will receive a set of Primacy 4 tyres with 6-Year MICHELIN warranty

(f) **How will the Customer receive the Prize.** The Prize Winner will redeem the set of tyres at Chin Seng Hin Pte Ltd

(g) **Where will Customers receive their Prizes.** The Prize will be awarded to the Prize Winner at Chin Seng Hin Pte Ltd

(h) **When will Customers receive their Prizes.** Chin Seng Hin Pte Ltd will notify the Prize Winner of the date and time after the contest has ended. The Prize Winner may redeem the set of tyres within 2 years from the end of the contest, the last day of the redemption would be 30<sup>th</sup> April 2023.

(i) Other Terms and Conditions apply.

If a court holds any provision of these Terms and Conditions to be illegal, invalid or unenforceable, the rest of these Terms and Conditions will remain in effect and these Terms and Conditions will be amended to give effect to the eliminated provision to the maximum extent possible.
11. Laws. The Contest shall be governed by and interpreted in accordance with the laws of Singapore. The Contest is void where prohibited or restricted by law, and is subject to all applicable laws.
