

TERMS AND CONDITIONS OF SALE FOR REPLACEMENT SALES

Last updated: January 2025

PREAMBLE

These "General Terms and Conditions" form the basis of all Michelin Suisse SA, Route jo Siffert 36, CH – 1762 Givisiez ("Michelin") offers and agreements, including the supply of Products on a non-exclusive basis to Customer as set forth in the relevant Order. Any order for Products or, where applicable, signature of these General Terms and Conditions, is Customer's unreserved acceptance of all provisions of these General Terms and Conditions. MICHELIN and Customer are referred to individually as a "Party" and collectively as the "Parties".

These Terms and Conditions, which are incorporated by this reference into any commercial agreement, commercial program, service contract or other agreement, contract, offer letter or purchase order, and any addendum or amendment thereto for the sale of Products by Michelin, are collectively or individually referred to as the "Agreement"

1. INTERPRETATION.

The following definitions and rules apply in these General Terms and Conditions:

1.1. **Definitions:**

Affiliate: an entity that is controlled by, controlling, or under common control with one of the Parties.

Business Day: a day that is not a Saturday, Sunday or public holiday in the country in which Michelin is based.

Day or calendar day: all calendar days of the civil year (i.e. including Sundays and public holidays)

Commercial Program: the most recent version of the MICHELIN price list made available to Customer and the Brand Program/the Commercial Terms and Conditions, as applicable.

Confidential Information: all non-public and proprietary information including, without limitation, know-how, intellectual property, ideas, drawings, designs, concepts, samples, models, plans, data, software, and other technical, operating, financial or commercial information that would be regarded as confidential by a reasonable business person, which is obtained directly or indirectly either before or after the date of these General Terms and Conditions by one Party from the other Party or by virtue of having communications with or being on the premises of the other Party in connection with the business relationship.

Domination and control: If a legal entity has the power, either directly or indirectly, to direct the management and policies of another legal entity, whether through ownership of a fraction of the share capital or by contract or otherwise.

Customer: any customer purchasing Products from MICHELIN.

Customer Data: refers to Customer's Technical Data and personal data.

Electronic Transmission: any form of communication, not directly involving the physical transmission of paper, that creates a record that may be retained, retrieved, and reviewed by a recipient thereof, and that may be directly reproduced in paper form by such a recipient through an automated process, provided that the transmission is secure and all actions are tracked and recorded by a reliable system, such record being able to be retained, retrieved and reproduced by the recipient and the sender.

Force Majeure Event: any circumstance beyond the reasonable control of the Party, such as acts of God, war, pandemic, epidemic, terrorism, civil disturbance, malicious damage, strike, disease outbreak, lockout, industrial action, lack or failure of transportation facilities, fire, flood, drought, extreme weather conditions, compliance with any law or governmental order, rule, regulation, direction or other circumstance beyond the reasonable control of either Party, provided that such Party could not reasonably be expected to have taken into account the occurrence and the effects of the occurrence upon its ability to perform hereunder, and that it could not reasonably have avoided the occurrence and overcome its effects.

Marks: the Michelin trademarks, trade names, common law rights, logos, slogans, signs, domain names, subdomains, keywords, and related goodwill.

Michelin Group: entities controlled by Compagnie Generale des Etablissements Michelin, 23 Place des Carmes Déchaux 63000 Clermont Ferrand, registration no. 855 200 887.

Michelin Group Positions: the positions taken by Michelin to refuse and prohibit any direct or indirect commercial activity involving Michelin Group products (including but not limited to sales to or in the country, and/or transit across the country) with certain countries. They may contain more restrictive positions than the Trade Restrictions and are based on commercial considerations and other compliance concerns, including, but not limited to, money laundering and corruption concerns, and concerns related to the financing of terrorism. They apply to the Products sold as spare parts or incorporated in a higher-level assembly (such as a fitted unit, a ground vehicle, a plane, etc.). As of the date of the General Terms and Conditions, the list of countries to which MICHELIN refuses and prohibits any direct or indirect sales (including transit across these countries) is Cuba, Iran, North Korea, and Syria. This list is subject to change in MICHELIN's sole discretion.

Order: any purchase order detailing the Products to be supplied by MICHELIN to Customer upon MICHELIN's acceptance in accordance with Section 2.2 (Acceptance).

Products: any goods, products and/or services provided by MICHELIN and as specified in the relevant Order.

Regional Terms Schedules: as applicable, terms and conditions specific to certain regions and/or countries attached to these General Terms and Conditions.



Restricted Person: any individual, entity, or body either: (i) specifically designated or listed under Trade Restrictions; (ii) owned or controlled by any person specifically designated or listed under Trade Restrictions; or (iii) acting for or on behalf of any person specifically designated or listed under Trade Restrictions.

Technical Data: all data entered by Customer and/or Michelin on Customer's behalf (excluding personal data) in relation to the Products offered by Michelin, directly or indirectly relating to tires and/or vehicles and/or their use, as well as any recommendations relating to Customer's fleet or business.

Trade Restrictions: trade sanctions (including but not limited to comprehensive or sectoral embargoes and restricted parties) and export controls (including but not limited to military or dual usage products).

- **1.2.** The applicable Regional Terms Schedules form part of these General Terms and Conditions and shall have effect as if set out in full in the body of these General Terms and Conditions. Any reference to these General Terms and Conditions includes the Regional Terms Schedules.
- **1.3.** Unless the context otherwise requires, a reference to one gender shall include a reference to the other genders.
- **1.4.** A reference to legislation or a legislative provision is a reference to it as amended, extended, or re-enacted from time to time
- **1.5.** All references to any mandatory local laws and/or regulations shall be contained in the Regional Terms Schedules appended to these General Terms and Conditions. The Regional Terms Schedules shall prevail in case of any contradiction with these General Terms and Conditions.
- **1.6.** In the event of a conflict with these General Terms and Conditions, the regional provisions shall prevail.

2. PLACEMENT, ACCEPTANCE AND DELIVERY OF ORDERS.

- **2.1.** Placement of Orders. Customer may order Products using the following methods: (i) online via Michelin's designated ordering platform. The use of the online platform to place orders does not restrict Customer's access to make an order(s) via email or telephone, if available; (ii) email; (iii) telephone; (iv) Michelin's representatives; and/or (v) Michelin customer service.
- **2.2.** <u>Acceptance.</u> All Orders are subject to acceptance by Michelin in its sole discretion. To the extent permitted by applicable mandatory law, Michelin may in its sole discretion:
 - **2.2.1.** unilaterally modify or cancel any Orders based on the availability and supply of the Products; and/or
 - **2.2.2.** freely allocate available Products between and among its Customers.
- 2.3. Michelin shall use reasonable efforts to fulfill Orders.
- **2.4.** Unless prohibited by mandatory local laws, Customer may not modify an Order.
- 2.5. **Delivery**. Delivery dates are indicative only and non-binding.
- **2.6.** Subject to Section 2.2 (Acceptance), in all instances, including when freight is prepaid, Michelin retains the right to select a carrier/delivery agent of Michelin's choice, and to ship to authorized Customer locations specified by Customer and agreed by the Parties. Products may be delivered in installments.

- **2.7.** Customer may, at its sole expense, pick up any order of MICHELIN Products from such warehouse as Michelin may designate and at such times as the Parties mutually agree, upon prior written agreement with Michelin.
- **2.8.** To the extent permitted by applicable mandatory law, and unless otherwise agreed in writing, Michelin does not accept any return or exchange of delivered Products except for defective Products, as detailed further in Section 6 (Customer's Acceptance or Rejection of Products).

3. TITLE AND RISK.

- **3.1.** Risk in the Products will pass to Customer upon delivery. Delivery shall take place when Products are delivered to: (i) Customer; or (ii) a third-party carrier of Customer's choice for transportation to Customer, whichever occurs first.
- **3.2.** To the extent permitted by applicable mandatory law, and subject to Section 4 (Customer Rights, Obligations and Restrictions), title to the Products shall pass to Customer upon receipt of payment in full of all sums and/or debts owed by Customer, howsoever created.
- **3.3.** Notwithstanding the provisions contained in Section 2 (Placement, Acceptance and Delivery of Orders) and this Section 3, and unless otherwise prohibited by applicable mandatory law, MICHELIN retains the right to stop delivery of Products in the event:
- **3.3.1.** Customer fails to pay any sum payable to Michelin under any Order;
- 3.3.2. Customer defaults in its performance of any obligation;
- 3.3.3. Customer becomes subject to an insolvency event; and/or
- 3.3.4. as otherwise permitted by applicable mandatory law.

4. CUSTOMER RIGHTS, OBLIGATIONS AND RESTRICTIONS.

- **4.1.** Subject to the provisions of these General Terms and Conditions, Customer has the non-exclusive right to purchase the Products from Michelin and to distribute the Products for resale in its own name and on its own behalf.
- **4.2.** Customer's obligations shall include, but are not limited to:
 - **4.2.1.** ensuring that the terms of the Order are complete and accurate:
 - 4.2.2. payment of all amounts owed to Michelin;
 - **4.2.3.** proper handling and sale of the Products in compliance with MICHELIN product information, particularly policies related to the storage, care, and transfer of the Products;
 - **4.2.4.** maintenance of the Products for the benefit of its customers/end-users against all risk that may arise following delivery;
 - **4.2.5.** possession and maintenance of all relevant and required business permits, licenses and/or approvals to enable Customer to carry out its business in compliance with all applicable laws, rules, and regulations; and
 - 4.2.6. conducting its business in a manner that will maximize the sale of Products by Customer while enhancing the reputation of and goodwill associated with the Marks and Products.
- **4.3.** Customer shall comply with all Michelin and Michelin Group policies and codes in force and as amended from time to time.
- **4.4.** Mutual obligations. Each party represents and warrants that: (i) it is a company duly incorporated and validly existing under the laws of the country in which it is located and has the requisite power and authority to enter into and fully perform the Agreement; (ii) the Agreement does not conflict with, violate or constitute a breach of any contractual, financial, business or legal obligation of any kind to



which the Party, its Affiliates and/or its employees are subject; and for so long as the Contract is in force, the Party, its Affiliates and/or its employees have not and will not enter into any obligation that constitutes a breach or otherwise materially and adversely affects the performance of its obligations under the Contract; (iii) it will at all times comply with all applicable laws and regulations; (iv) it has obtained and will maintain at its own expense all permits, licenses and consents necessary to perform its obligations under the Contract; (v) it will employ personnel who have the requisite level of qualifications, experience, training and skills to perform the duties assigned to them and who are familiar with the requirements of the Contract.

5. INTELLECTUAL PROPERTY AND CUSTOMER'S NON-DISPARAGEMENT OF PRODUCTS BEARING MICHELIN MARKS.

5.1. Intellectual Property.

- 5.1.1. Michelin retains all rights, title and interest in the Marks referring to its Products in any country or region. Customer agrees not to oppose, invalidate, or impair the Marks in any way.
- 5.1.2. Customer recognizes and acknowledges that it shall have no ownership of, or rights whatsoever in, the Marks or other names and signs affixed to the Products it distributes, nor on any promotional materials and their contents provided by Michelin. Customer shall not take any steps to register or otherwise acquire any rights in respect of such Marks or of any similar name, logo or sign likely to create confusion. Customer is not authorized to use any Marks as part of Customer's corporate name or domain names.
- 5.1.3. Michelin hereby grants to Customer a non-exclusive, nontransferable, limited right to use such Marks in Customer's business solely for the purpose of advertising, promoting, selling, and distributing the Products in strict compliance with Section 4.2.6 above. No other use of the Marks is authorized in any way whatsoever. Upon termination of the contractual relationship between Michelin and Customer for any reason whatsoever, Customer shall immediately refrain from using the Marks under any form whatsoever, without prejudice to Customer's right to sell Products in its inventory on the date of such termination. Customer undertakes that within seven (7) business days of such termination for any reason, it shall remove and return to Michelin all signboards comprising any Marks in any locations and all documents provided to Customer by Michelin. All powers are hereby granted to Michelin to proceed with any such dismounting after the end of the identified period at Customer's costs.
- 5.1.4. Notwithstanding anything to the contrary, Michelin retains all rights, title and interest in all other intellectual property rights including without limitation patent rights, provisional patent rights, designs, copyrights, software, databases (collectively referred to as the "Other IPRs") protecting its Products, processes, and services, as well as documentation and content provided by Michelin, in any country or region. No rights or licenses are granted on Other IPRs under these General Terms and Conditions beyond the non-exclusive, limited right, to use the Products purchased from Michelin for their intended purpose.
- 5.1.5. Except as otherwise dictated by applicable mandatory law, the supply or use of the Products is conditional upon Customer's undertaking not to seek, by reverse engineering, disassembly, or any other analysis, to obtain the methodology, composition, formulation, components, processes, source code or any other confidential information relating to the Products.
- **5.1.6.** The Michelin Group's guidelines on correct use of the Marks apply and shall be adhered to by Customer. The

- guidelines are available at www.michelin.com. Customer agrees that Michelin may object to any advertising, marketing and/or promotional materials which do not comply with such guidelines and that Customer shall promptly cease the use of such materials upon Michelin's request.
- 5.1.7. Any misuse of the Marks by Customer shall constitute a material breach of these General Terms and Conditions, and Customer agrees to indemnify Michelin for any and all damages caused by Customer's breach.
- **5.1.8.** Any use of the Marks by Customer according to these General Terms and Conditions shall inure exclusively to the benefit of Michelin.
- 5.1.9. To the extent permitted by applicable mandatory law, Customer shall keep Michelin informed, as soon as becoming aware of: (i) any potential or actual infringement, piracy, or unfair competition by third-party(ies) in relation to the Marks; (ii) any third-party claims or actions against the validity, registration and use of the Marks; or (iii) any third-party claims or actions relating to the use of or the intent to use the Marks.
- **5.1.10.** In the event of termination of these General Terms and Conditions, Sections 12.6 and 12.7 (Effects of termination) shall apply.

5.2. Non-Disparagement.

- 5.2.1. Customer undertakes not to disparage, either directly or indirectly, the Marks or Products or to bring the Marks or Products into disrepute. In this respect, Customer shall notably refrain from any public statement or comment, press release or communication on social networks referring negatively to the Marks or Products including but not limited to: (i) the performance, quality, technology, durability, or capacities of the Products; (ii) the validity, registration, or ownership of the Marks; or (iii) the reputation or conduct of Michelin or any of Michelin 's representatives, employees, subcontractors, agents, or service providers.
- 5.2.2. Customer undertakes not to organize advertising or more generally any communication of any nature whatsoever, which could harm the name and/or reputation of MICHELIN, the Marks and/or the Products.

6. CUSTOMER'S ACCEPTANCE OR REJECTION OF PRODUCTS.

- **6.1.** Upon delivery, Customer must inspect the Products for any defects (in particular, any discrepancies in relation to the quantity, assortment, quality, type ordered, or any soiling).
- **6.2.** Any defects identified by Customer upon delivery must be notified: (i) to the third-party carrier at the time of delivery (written comment on transport documentation); and (ii) immediately in writing to Michelin.
- **6.3.** Unless otherwise dictated by applicable mandatory law, with respect to any hidden or other defects identified after delivery, Customer will notify Michelin in writing immediately upon becoming aware of such defects in accordance with local laws and regulations.
- **6.4.** Michelin retains the right to verify any defects identified by Customer under this Section 6. To the extent permitted by applicable mandatory law, Customer's remedy for any defects will be decided by Michelin in its sole discretion.
- **6.5.** Subject to Sub-Sections, 6.2 and 6.3 above, the Products will be deemed accepted by Customer upon delivery and, where applicable, upon Customer's signing of the delivery receipt.



6.6. Failure to comply with this Section 6 will result in full and complete waiver of any claim or liability against Michelin for any defects in the Products.

7. PRICING, INVOICING AND TAXES.

- **7.1.** <u>Pricing.</u> The price payable by Customer for the Products shall be the price set out in the Commercial Program at the date of shipment or collection, or where services are being provided, the date the service is performed, and under the terms of the Commercial Program valid on this date.
- **7.2.** Michelin may change the following at any time, and unless prohibited by applicable mandatory law, without prior notice to Customer: (i) Michelin price lists; and/or (ii) other pricing or sales materials distributed by Michelin.
- **7.3.** Michelin shall independently determine the prices of Michelin Products payable by Customer to Michelin. Customer shall independently determine the prices at which it will resell Michelin Products.
- **7.4.** <u>Invoicing.</u> The invoice shall include, unless prohibited by applicable mandatory law, any bonuses, incentives, or such other arrangements contained in the Commercial Program (if applicable) between Customer and Michelin, and all applicable taxes, duties, and fees.
- **7.5.** <u>Taxes.</u> All prices are exclusive of any applicable taxes, duties, or fees.
- **7.6.** Customer represents, warrants, and certifies that Products purchased from Michelin are for resale or direct use in the ordinary course of Customer's business, and that Customer is registered for tax purposes and required to collect and remit, any and all applicable sales or use taxes, or tire waste/recycle fees incurred in any such resale transactions. Customer agrees to furnish proof thereof to Michelin. As to any Products or other tangible property put to a taxable use by Customer and any item previously exempted from a tax or fee in lieu of or prior to resale, Customer shall make timely return and payment to the proper taxing authority of all applicable taxes to include tire waste/recycle fees and Customer shall notify Michelin of such use and pay Michelin any applicable taxes on Products previously exempted.

8. PAYMENT.

- **8.1.** Customer shall pay for the Products in accordance with Michelin 's invoice to Customer, or in such other manner as Michelin may prescribe in its sole discretion.
- **8.2.** Unless otherwise agreed between the Parties, cash payments or any other kind of payment in advance by Customer will not result in a discount in the pricing.
- **8.3.** Where payment by Customer is made by cheque or other negotiable instrument, payment will be taken to have been made only when the cheque or instrument is honored, and the amount of the cheque/negotiable instrument is realized by Michelin.
- **8.4.** The date of payment shall be the date on which the funds are credited to the Michelin bank account specified in the invoice.
- **8.5.** If Customer disputes any Michelin invoice, it shall notify MICHELIN of any disputes/claims within thirty (30) calendar days of invoice date or credit document date and shall pay Michelin the balance due on the portion of the invoice that Customer does not dispute in accordance with the terms of the invoice.

- **8.6.** Notwithstanding anything contained to the contrary herein, and unless otherwise prohibited by applicable mandatory law, Michelin shall have the right at any time and in its sole discretion to:
 - **8.6.1.** establish and make modifications to payment terms;
 - **8.6.2.** grant or discontinue any extension of open account trade credit to Customer; and
 - **8.6.3.** require a direct debit mandate, advance payment, cash on delivery or cash payment for deliveries, or other security for shipments.
- **8.7.** If Michelin determines that sales to Customer should be on credit, Michelin shall reserve the right to fully and discretionally request any collateral that it may deem appropriate and necessary in accordance with the credit line granted to Customer, and such collateral shall maintain its validity until termination hereof or if its agreements are amended and Customer has duly complied with all the obligations contained under these General Terms and Conditions.
- **8.8.** Michelin may demand assurances from Customer that payment, in conformity with the provisions of these General Terms and Conditions, shall be forthcoming. Until assurances satisfactory to Michelin are received from Customer, Michelin shall have the right to discontinue or suspend Customer's privileges under these General Terms and Conditions.
- **8.9.** In addition to any right of setoff or recoupment permitted by law, Michelin shall in its sole and absolute discretion have the contractual right to apply:
 - **8.9.1.** any amounts owed by Michelin or any Affiliate of Michelin (including but not limited to credits, bonuses or rebates earned or payable under any Commercial Programs) to Customer (or any person or entity affiliated with Customer) under other contractual agreements; or
 - **8.9.2.** any payments made by Customer or credits issued to Customer under any contractual relationship, to reduce any amounts due to Michelin under these General Terms and Conditions.
- **8.10.** Customer shall reimburse Michelin for all charges and costs, including, but not limited to, reasonable attorneys' fees, which Michelin incurs in enforcing these General Terms and Conditions, the Commercial Program or any related agreement including, but not limited to, any security or credit agreement.
- **8.11.** All amounts owed to Michelin by Customer under these General Terms and Conditions, or any other contractual relationship shall become immediately due and payable on termination of these General Terms and Conditions for any reason.

9. LATE OR NON-PAYMENT; CHANGE OF FINANCIAL STATUS.

- **9.1.** Late or non-payment. Subject to Section 8.5, Customer's failure to make full payment to Michelin under these General Terms and Conditions by the due date will constitute a material breach of these General Terms and Conditions. Accordingly, without prejudice to any remedies available to Michelin under these General Terms and Conditions and at law, in the event Customer fails to make full payment:
 - 9.1.1. Michelin shall be entitled to late payment interest;
 - **9.1.2.** to the extent permitted by applicable mandatory law, Michelin may in its sole discretion terminate any other contract between the Parties;
 - 9.1.3. to the extent permitted by applicable mandatory law, Michelin may at its sole discretion suspend delivery of Products to Customer, cancel undelivered Orders or refuse



- shipment of any further Products, and/or suspend the performance of any services;
- **9.1.4.** to the extent permitted by applicable mandatory law, Customer's authorization to resell the Products will automatically terminate;
- 9.1.5. unless prohibited by applicable mandatory law, MICHELIN reserves the right to immediately claim the Products, on the understanding that the Products still held by Customer will be presumed to be those that have remained unpaid. All costs of taking back the Products and restoring the Products will be borne by Customer. The return of unpaid Products will be due by the defaulting Customer at its own expense and risk, upon notice from Michelin; and
- 9.1.6. all amounts owed to Michelin by Customer under these General Terms and Conditions or any other contractual relationship between the Parties shall become immediately due.
- **9.2.** Any acceptance of late payments by Michelin will not alter these General Terms and Conditions or act as a waiver of the payment terms contained herein.
- **9.3.** Change of financial status. To the extent permitted by applicable mandatory law, Michelin may suspend delivery of any current Orders, and not resume deliveries if:
 - 9.3.1. insolvency proceedings have been initiated against Customer, and no written agreement has been reached between Customer and Michelin detailing the ongoing delivery of Products; or
 - **9.3.2.** Customer's financial situation deteriorates substantially as reasonably determined by Michelin.
- **9.4.** Customer's entitlement to resell the Products, subject in all cases to the terms of Section 3 (Title and Risk) will expire immediately upon such suspension. In such cases, Customer must allow Michelin's agent(s) to take any measures on Customer's premises Michelin deems appropriate and necessary to preserve and enforce the rights Michelin holds in connection with the lien.

10. ETHICS AND COMPLIANCE.

- 10.1. As of the signature date of these General Terms and Conditions, or the placement of an Order by Customer when these General Terms and Conditions are not signed, each Party undertakes to have or to implement and maintain an anti-bribery and anti-corruption compliance program, adapted to its own situation and able to detect corruption and promote a culture of integrity in its organization. Each Party acknowledges a "zero tolerance" policy regarding bribery and corruption and agrees to comply with applicable laws and regulations regarding the fight against bribery and corruption.
- **10.2.** Each Party agrees to refrain from: (i) offering, promising or giving; and from (ii) attempting or conspiring to offer, promise or give, any undue pecuniary or other advantage, whether directly or through intermediaries, to a public or private official or representative for that official or representative or for a third-party, in order that the official or representative acts or refrains from acting in relation to the performance of official duties, in order to obtain or retain business or other improper advantage. Michelin may conduct compliance audits on Customer to ensure its compliance with the above commitments.
- **10.3.** In the event Customer fails to comply with the requirements of this Section 10, Customer undertakes to immediately inform Michelin and to attempt to correct the non-compliance within a reasonable timeframe. Notwithstanding the above, Michelin reserves

the right to take any appropriate measures to mitigate corruption risk, including termination of the Order, these General Terms and Conditions, and/or any other contractual relationship between the Parties.

- **10.4.** Customer shall comply with and shall require that all of its commercial partners (customers and suppliers) and sub-contractors comply with all applicable laws, statutes, codes and regulations including but not limited to those relating to anti-corruption, anti-bribery, anti-money laundering, fraud, health and safety, environment (as well as avoid any practices that may cause damage to it, especially, but not limited to, regarding any practices that can contribute to the rise in deforestation, burnt land and soil erosion), labor law, human rights, harassment, and discrimination.
- 10.5. Customer shall conduct its business with integrity, ethics, and transparency, and shall adopt, promote, and comply with fundamental rules in the areas of human rights, labor, environmental, ethics, fraud, anti-bribery, and anti-corruption standards. MICHELIN makes available to its customers an Ethics Line which they are entitled to use in case of violations of the MICHELIN Code of Ethics (available at the following link: https://ethique.michelin.com/en/) or the anti-corruption compliance program. Alerts can be submitted through the following link: https://michelingroup.ethicspoint.com/

11. TRADE RESTRICTIONS.

- 11.1. Customer shall comply with all applicable laws and regulations with regard to the supply, sale, transfer, export, retransfer, or re-export of the Products, including but not limited to, those relating to Trade Restrictions. For the avoidance of doubt, all applicable laws and regulations could include those originating out of the United Nations, the European Union, the OSCE, or the United States of America.
- **11.2.** Customer shall not cause MICHELIN to, either directly or indirectly, risk any potential violation of any applicable Trade Restrictions. Furthermore, Customer will not supply, sell, transfer, export, re-transfer, re-export, otherwise make available or use any Product supplied by MICHELIN in order to circumvent, evade or avoid any applicable Trade Restrictions.
- **11.3.** Where MICHELIN has reasonable cause to suspect that any Product may be or has been supplied, sold, transferred, exported, re-transferred, re-exported, otherwise made available to any jurisdiction targeted by relevant Trade Restrictions, or to a Restricted Person, or for any use, purpose or activity which is prohibited or otherwise restricted under Trade Restrictions, MICHELIN reserves the right to:
 - **11.3.1.** immediately suspend its performance under these General Terms and Conditions or any contractual relationship;
 - 11.3.2. request further information or documentary evidence from Customer, including but not limited to licenses, end user certificates, shipping, or commercial documentation, in order to verify the end use(s) or end user(s) of the Products; or
 - **11.3.3.** take any other appropriate measures regarding its commercial relationship with Customer.
- **11.4.** Customer certifies that, as of the date hereof, neither Customer, nor any of Customer's group companies, nor any of their respective directors or officers is a Restricted Person. Customer shall immediately notify Michelin if any of the abovementioned Customer, Customer group companies, directors, or officers becomes a Restricted Person.
- **11.5** Sanctions and export control in relation to Russia, Belarus and sanctioned regions of Ukraine (Crimea region and Donetsk,



Kherson, Luhansk and Zaporizhzhya oblasts and all other regions of Ukraine that could be sanctioned in the future):

- 11.5.1. The customer shall not sell, export, re-export or transit for use in Russia, Belarus or the sanctioned regions of Ukraine, directly or indirectly, any goods or technology supplied under or in connection with this contract that fall within the scope of the sanctions regimes imposed by the relevant jurisdictions (in particular the United States of America, European Union, Canada, United Kingdom) for the territories listed above. The customer shall not take any action that could result in companies or Michelin employees being held liable under these sanctions regimes. For the avoidance of doubt, the customer receiving products originating in or subject to the jurisdiction of the United States is prohibited from directly or indirectly exporting, re-exporting, transferring to or through, or using the products in the countries and territories listed above.
- **11.5.2.** The Customer shall use its best endeavors to ensure that the purpose of paragraph 11.5.1 is complied with by all third parties in the further chain of trade, including potential resellers.
- 11.5.3. The customer shall establish and maintain an appropriate monitoring mechanism to detect any behavior by third parties in the wider trade chain, including potential resellers, that would run counter to the objective of section 11.5.1 The Client is also aware of the potential criminal law risks associated with circumventing the sanctions imposed on these countries or regions by using third countries that do not impose sanctions on these countries or regions. As a result, the customer agrees to conduct appropriate due diligence when using or trading Michelin products or services, including the identification of "red flags" to avoid involving products, services, companies or Michelin employees in any transaction or activity that could expose them to potential liability under applicable sanctions regimes.
- **11.5.4.** Any violation of Sections 11.5.1, 11.5.2 or 11.5.3 shall constitute a material breach of a material element of the Agreement, and Michelin shall be entitled to seek appropriate remedies and take appropriate action, including, but not limited to:
 - the immediate suspension of the Agreement; and/or
 - immediate termination of the Agreement; and
 - liquidated damages of up to 100% of (i) the total value of the Agreement or (ii) the price of the goods and services sold or exported, whichever is greater.
- **11.5.5**. The client shall inform Michelin immediately of any information or findings that indicate non-compliance with sections 11.5.1, 11.5.2 or 11.5.3 including in particular any relevant activities of third parties that could run counter to the purpose of section 11.5.1. The customer shall provide Michelin with all information on compliance with the obligations under sections 11.5.1, 11.5.2 and 11.5.3 as soon as possible after the written request for this information.
- 11.6. The Customer shall indemnify and hold MICHELIN harmless from and against any losses, costs, claims, Michelin of action, damages, liabilities and expenses, including attorneys' fees, litigation and settlement costs and court costs, resulting from the Customer's failure to comply with the Trade Restrictions or Michelin Group's positions. The Customer shall be liable for all acts and omissions of the Buyer, its officers, employees, affiliates, agents, suppliers or subcontractors of any tier committed in the performance of its obligations under this Section 11.
- **11.7** The Customer must comply with the Michelin Group's positions, which may contain provisions that are stricter than the trading restrictions set out in these General Terms and Conditions.

12. TERMINATION.

- **12.1.** <u>Termination for convenience</u>. Without affecting any other right or remedy available to it, and to the extent permitted by applicable mandatory law, Michelin may terminate these General Terms and Conditions without cause, at any time without charge, upon thirty (30) calendar days' prior written notice of such termination to Customer.
- **12.2.** <u>Termination for material breach</u>. Without affecting any other right or remedy available to Michelin, if Customer materially breaches its obligations under these General Terms and Conditions, Michelin may terminate these General Terms and Conditions and any other contractual relationship with immediate effect by giving written notice to Customer:
 - **12.2.1.** if Customer fails to remedy such material breach within fourteen (14) calendar days of being notified in writing by Michelin to do so; or
 - **12.2.2.** where Customer's material breach is incapable of remedy, as determined by Michelin in its sole discretion.
- **12.3.** <u>Termination for dissolution.</u> Either Party may terminate these General Terms and Conditions and/or any other contractual relationship between the Parties, immediately without notice in the event of dissolution of either Party, whether by operation of law or otherwise.
- **12.4.** Termination for bankruptcy. To the extent permitted by applicable mandatory law, either Party may terminate these General Terms and Conditions and/or any other contractual relationship between the Parties, immediately without notice if, in the opinion of the terminating Party, the other Party, its principle, or any owner or guarantor of that Party's business becomes insolvent or is likely to become insolvent.
- **12.5.** MICHELIN's right to terminate for change of control or <u>assignment</u>. MICHELIN may terminate these General Terms and Conditions and/or any other contractual relationship between the Parties immediately upon:
 - **12.5.1.** any change of control of Customer, as defined by applicable law, unless prior to the occurrence of such change of control, Michelin is notified of the change in writing and gives written approval; or
 - **12.5.2.** any attempted assignment by Customer of these General Terms and Conditions or any right or interest arising from these General Terms and Conditions without the prior written consent of Michelin.
- **12.6.** <u>Effects of termination.</u> Upon termination of these General Terms and Conditions for any reason whatsoever, Customer shall immediately refrain from using the Marks in any form whatsoever, without prejudice to Customer's right to sell Products in its inventory on the date of termination of these General Terms and Conditions.
- **12.7.** Customer undertakes that, within thirty (30) calendar days of termination of these General Terms and Conditions for any reason, it shall remove and return to Michelin all signboards comprising any Marks in any locations and all documents provided to it by Michelin. All powers are hereby granted to Michelin to proceed with any such dismounting after the end of the identified period at Customer's cost.
- **12.8.** All sums owing by Customer to Michelin or vice versa shall become immediately due and payable. To ensure prompt payment, each Party agrees to cooperate and work with the other in determining and processing all such amounts due. Michelin shall have the right to apply any amounts owed by Michelin or any Affiliate (including but not limited to credits, bonuses or rebates earned or payable under these General Terms and Conditions) to Customer (or any person or entity affiliated with Customer) in reduction of any amounts due to Michelin.



13. CONFIDENTIALITY.

- **13.1.** Subject to Section 13.4 below, each Party agrees that it will not disclose to any person any Confidential Information of, or relating to, the other Party which has been disclosed to it or which has come into its possession as a result of the execution of these General Terms and Conditions or other contractual relationship between the Parties for the duration of these General Terms and Conditions or other contractual relationship between the Parties and for an additional period of two (2) years from termination of the abovementioned contractual relationships between the Parties.
- **13.2.** Confidential Information may only be used by each Party to fulfill the purpose of these General Terms and Conditions and may only be shared with employees, Affiliates, and agents of the Parties in furtherance of the purpose of these General Terms and Conditions. For the avoidance of doubt and pursuant to applicable antitrust rules and regulations, distributors are considered as third parties and thereby excluded from the definition of Affiliate for the purposes of this Section 13.
- **13.3.** Each Party will protect the Confidential Information using the same degree of care it employs for its own similar information, but in any case, not less than a reasonable degree of care.
- **13.4.** Nothing in these General Terms and Conditions shall prohibit disclosure of information which: (i) is already in the public domain; (ii) becomes part of the public domain after disclosure to the receiving Party other than as a result of a wrongful act of such Party; (iii) is received from a third party providing that it was not acquired directly or indirectly by such third party from the receiving Party; or (iv) is required to be disclosed by law or any governmental or regulatory body or agency.

14. PRODUCT WARRANTY AND RECALL.

- **14.1.** General. Michelin will comply with mandatory local laws and the limited warranty statements provided with the Products or otherwise made available to Customer.
- **14.2.** Unless stated otherwise in the relevant Product warranty document, the Product warranty will begin from the date the Products are delivered to Customer.
- **14.3.** To the extent applicable, Customer undertakes to be the intermediary with respect to claims by its end users/customers, and Michelin will engage directly with Customer with respect to any warranty claims.
- **14.4.** The Product warranty will not apply to any claim or complaint based on circumstances arising from Customer's handling, assembly, commissioning, use or service of the Products in a manner that is not consistent with these General Terms and Conditions or Michelin's product information.
- **14.5. Product recall.** Customer and Michelin agree to comply and follow relevant mandatory laws applicable with regard to procedures and requirements of a Product recall.

15. <u>LIMITATION OF LIABILITY.</u>

- **15.1.** Regardless of the basis for liability, any claims for compensation made by Customer will be subject to the limitations stated in this Section 15.
- **15.2.** To the extent permitted by applicable mandatory law, MICHELIN shall not be liable for any loss, damages or penalties incurred by Customer:

- **15.2.1.** arising from any delay, failure, or inability to supply or deliver any Products, including, but not limited to any shortage of raw materials; or
- **15.2.2.** arising from or in connection with the fulfilment of Customer's obligations towards third parties.
- 15.3. LIMITATION OF LIABILITY. SUBJECT TO SECTION 15.4 (DISCLAIMER) BELOW, AND UNLESS **OTHERWISE** PROHIBITED BY APPLICABLE MANDATORY LAW, MICHELIN'S TOTAL LIABILITY TO CUSTOMER FOR ALL DIRECT DAMAGES INCURRED BY CUSTOMER UNDER THESE GENERAL TERMS AND CONDITIONS SHALL NOT EXCEED THE ACTUAL DAMAGES SUFFERED BY CUSTOMER WHICH IN ANY EVENT IS LIMITED TO THE TOTAL AMOUNT INVOICED BY MICHELIN TO CUSTOMER FOR THE TWELVE (12) MONTHS PRECEDING THE DATE OF THE LOSS OR DAMAGE. IN NO EVENT SHALL EITHER PARTY BE LIABLE TO THE OTHER FOR SPECIAL, INDIRECT, INCIDENTAL, CONSEQUENTIAL, EXEMPLARY, TREBLE, PUNITIVE, MULTIPLE OR ENHANCED DAMAGES, OR FOR LOST PROFITS, LOST REVENUES, OR DIMINUTION IN VALUE, ARISING OUT OF OR RELATING TO THESE GENERAL TERMS AND CONDITIONS OR EITHER PARTY'S PERFORMANCE HEREUNDER.
- 15.4. <u>DISCLAIMER</u>. MICHELIN DOES NOT WARRANT THAT ANY ONLINE PLATFORM USED TO ORDER PRODUCTS (OR ANY DATA OR INFORMATION MADE AVAILABLE THROUGH SUCH PLATFORM) WILL BE UNINTERRUPTED, SECURE, ACCURATE, COMPLETE, ERROR FREE, FREE OF VIRUSES OR HARMFUL CODE OR COMPATIBLE WITH OR WORK WITH OTHER SYSTEMS, SOFTWARE OR SERVICES; NOR DOES IT MAKE ANY WARRANTY AS TO THE RESULTS THAT MAY BE OBTAINED FROM USE OF THE PLATFORM.
- **15.5.** The limitation of liability set out in this Section 15 shall not apply to:
 - **15.5.1.** death or bodily injury caused by the intentional acts or gross negligence of Michelin;
 - **15.5.2.** damages arising directly from fraud or willful repudiation of these General Terms and Conditions by Michelin;
 - **15.5.3.** any other liability that may not be excluded or limited under applicable mandatory law; or
 - **15.5.4.** a Party's obligation to indemnify and defend the other against certain third-party claims.
- **15.6.** <u>Limitation of Action.</u> To the extent permitted by applicable mandatory law, no suit or claim based on any legal claim, regardless of form, arising out of or in any way connected with these General Terms and Conditions, may be brought by Customer (or any party claiming by, through, or under Customer) more than one (1) year after the event giving rise to such claim.

16. INDEMNITY.

- **16.1.** <u>Indemnification by Customer.</u> Customer shall indemnify Michelin against any losses, damages, liabilities, claims, costs, or out-of-pocket expenses (including any legal fees) incurred by Michelin in connection with these General Terms and Conditions and/or other contractual relationship between the Parties, including but not limited to:
 - 16.1.1. any use, misuse, distribution or redistribution or other actions taken (or not taken) by Customer, its officers, employees, Affiliates, agents, suppliers, or subcontractors;
 - **16.1.2.** Customer's failure to obtain the relevant business permits, licenses and/or approvals;



- **16.1.3.** Customer's failure to promptly pay any sales, excise, income, or other tax, or from Customer's failure to correctly file any required tax returns; and/or
- 16.1.4. Customer's breach of these General Terms and Conditions and/or any other contractual relationship between the Parties,

except to the extent such losses are caused by the fraud, gross negligence, or willful misconduct of Michelin in the performance of its obligations under these General Terms and Conditions and any other contractual relationship.

- **16.2.** <u>Intellectual Property Indemnification.</u> Michelin shall indemnify Customer against any losses, damages, liabilities, claims, costs, or out-of-pocket expenses (including any legal fees) incurred by Customer arising from any claim or suit alleging that the use of the Marks or the sale of the Products infringes any trademark, copyright, or patent of third parties, provided however that:
 - 16.2.1. this Section 16 does not cover, and Michelin has no obligation hereunder for, infringement claims or suits arising from Customer's failure to use the Marks or Products in accordance with these General Terms and Conditions or other contractual relationship; and
 - **16.2.2.** Customer shall provide Michelin with prompt notice of the claim or suit giving rise to such obligation; and
 - 16.2.3. MICHELIN shall have the sole control of the defense and of all negotiations for settlement of such claim or suit. Customer shall cooperate with Michelin in the defense or settlement of any such claim or suit.
- **16.3.** If a claim or suit for which Michelin is required to indemnify Customer under this Section 16 is brought or is likely to be brought, MICHELIN may require Customer to immediately discontinue the use of the Marks and/or the sale of the Products and Customer shall comply with such requirement.
- **16.4.** This Section 16 shall survive termination of these General Terms and Conditions.
- 16.5. THIS SECTION 16 SETS FORTH THE ENTIRE POTENTIAL LIABILITY OF EACH PARTY AND THE SOLE AND EXCLUSIVE REMEDY OF THE OTHER PARTY FOR ANY CLAIM OR ACTION BROUGHT BY A THIRD PARTY BASED ON AN INFRINGEMENT OF SUCH THIRD PARTY'S INTELLECTUAL PROPERTY RIGHTS.USE OF CUSTOMER DATA AND PRIVACY.
- **16.6.** This Section 16 shall also apply after termination of the contract.

17. USE OF CUSTOMER DATA AND DATA PROTECTION.

17.1. CUSTOMER DATA.

- 17.1.1. <u>Customer Warranties.</u> Customer represents and warrants that any and all Customer Data provided and/or uploaded to Michelin is true, accurate, current, and complete in all respects.
- 17.1.2. Right to Use Customer Data. Customer expressly authorizes Michelin and its Affiliates and/or its subcontractors, either directly or indirectly through third party contractors, to store, access, process, copy, run, purge and/or erase Customer Data (including for the avoidance of doubt Customer personal data) stored in a

Michelin database to the extent it relates to the Products provided by Michelin and/or to the extent necessary for the implementation of any obligations under these General Terms and Conditions. Similarly, Customer authorizes Michelin and/or its Affiliates and/or subcontractors to purge and/or erase Customer Data that does not present the necessary guarantees in connection with the Products provided by Michelin (or in case of reasonable doubt) or in accordance with the applicable legal provisions.

- **17.1.3.** Right to Use Technical Data. Technical Data may be used worldwide by Michelin, its Affiliates and/or its subcontractor(s) in order to:
 - (i) implement its obligations under these General Terms and Conditions;
 - (ii) offer Customer additional services such as its own individualized reporting against consolidated data; and/or
 - (iii) create and/or expand any database which may be used for consolidated data reporting, statistic, referential and/or benchmark analysis, marketing purposes, research, and/or future product development purposes while these General Terms and Conditions are in effect and any time thereafter within the context of Michelin and its Affiliates and/or its subcontractor(s) provided that such Technical Data is anonymized (understood that no direct or indirect link can be made between such data and Customer).
- 17.1.4. Except for the rights granted under Sub-Section 17.1.3 (iii) above, which is granted for the maximum legal duration of protection of intellectual property rights, the right to use Technical Data shall expire at the end of these General Terms and Conditions, irrespective of cause.

17.2. DATA PROTECTION.

- 17.2.1. Each Party undertakes, for the personal data processing operations it carries out for its own purposes under and in the framework of these General Terms and Conditions to comply with all obligations arising from the application of any applicable data protection and privacy legislation and regulatory requirements in force and as amended from time to time, that may apply to personal data processed, including those of the General Data Protection Regulation (EU/2016/679) and its possible updates and existing local laws, or any other data protection legislation applicable outside of the European Union (together the "Data Protection Legislation").
- 17.2.2. Customer acknowledges that, Michelin, as data controller, or the like, of the personal data received from Customer, processes personal data for the purpose of managing operations relating to the contractual relationship with its Customers, in compliance with the Data Protection Legislation. The processing is based on MICHELIN's legitimate interest related to performance of these General Terms and Conditions. Accordingly, unless otherwise provided by applicable Data Protection Legislation, Customer undertakes to inform data subjects (for example, its employees) of such personal data processing and any personal data processed under these General Terms and Conditions concerned is kept for the duration of the contractual relationship plus the legal limitation periods.



- 17.2.3. Processed data may be used by Michelin 's relevant departments and, where appropriate, its sub-processors, some of which may be located outside the country of origin of the personal data, such as, the EU, the USA and India. In order to provide adequate safeguards for the transfer of such personal data, cross-border data transfer agreements incorporating standard clauses of the European Commission have been signed between Michelin and its sub-processors. Transfers within the Michelin Group may also take place and are governed by the Michelin Group's Binding Corporate Rules which have been validated by the French Data Protection Authority (available at https://Michelin.co/de/).
- 17.2.4. Where personal data is transferred outside of the European Economic Area, Michelin shall ensure appropriate safeguards are implemented and/or adopted, including but not limited to the Standard Contractual Clauses.
- 17.2.5. To the extent dictated by applicable mandatory law, data subjects shall benefit, under the conditions stipulated by law, from a right of access, rectification, portability, restriction of processing, opposition for legitimate reasons, and deletion. Data subjects seeking to exercise their rights shall contact MICHELIN. If the data subject's requests are unsatisfied, they may file a complaint with the relevant data protection authority.

18. FORCE MAJEURE.

- **18.1.** <u>Impacts of Force Majeure.</u> Each Party shall be relieved from liability for a failure to perform any obligation under these General Terms and Conditions during such period and to the extent that the due performance thereof by such Party is prevented by reason of a Force Majeure Event.
- **18.2.** To the extent permitted by applicable mandatory law or regulation, Customer will not be relieved of its duty to make payments to Michelin due to any Force Majeure Event.
- **18.3.** <u>Notice and duty to mitigate.</u> A Customer desiring to invoke a Force Majeure Event hereunder shall give notice to Michelin as soon as possible but no later than 30 calendar days after the commencement of such Force Majeure Event. Customer shall not be discharged from liability for any non-performance caused by such Force Majeure Event should it fail to notify Michelin in accordance with this Section 18.3.
- **18.4.** Both Parties shall make all reasonable efforts to prevent and reduce the effect of any non-performance of these General Terms and Conditions caused by a Force Majeure Event. In the event of shortage of production or supply of Products for any reason, subject to applicable mandatory law, Michelin reserves the right to allocate its supply of Products to itself and such other customers in its sole discretion without incurring any liability to Customer arising therefrom.

19. GOVERNING LAW, JURISDICTION, AND DISPUTE RESOLUTION.

- **19.1.** These General Terms and Conditions will be governed by the laws of the legal jurisdiction where the MICHELIN entity issuing the General Terms and Conditions is incorporated.
- **19.2.** Where applicable, application of the United Nations Convention on Contracts for the International Sale of Goods is hereby excluded.

- **19.3.** In the event of a dispute arising from or in connection with these General Terms and Conditions, and before filing any action in a court of competent jurisdiction, the Parties may attempt in good faith to resolve such dispute within thirty (30) calendar days by negotiation between representatives who have authority to settle the dispute.
- **19.4.** Notwithstanding Section 19.3 above, in the event a dispute cannot be resolved through negotiation, the courts of the competent jurisdiction in the location of the Michelin entity's registered office issuing these General Terms and Conditions will have jurisdiction to settle all disputes arising from or in connection with these General Terms and Conditions.
- **19.5.** Notwithstanding the other provisions of this Section 19, to the extent permitted by applicable mandatory law, Michelin may also seek equitable relief or an interim injunction in a court of competent jurisdiction.

20. MISCELLANEOUS TERMS.

- **20.1.** <u>Subcontracting</u>. Michelin may subcontract any or all of its obligations under these General Terms and Conditions without notice to Customer. Notwithstanding the foregoing, Michelin will be responsible for the acts and omissions of any such subcontractor.
- **20.2.** Assignment. Customer may not assign these General Terms and Conditions, or any of its rights or obligations hereunder, without Michelin's prior written consent. Any assignment by Customer shall be null and void. These General Terms and Conditions and any right hereunder or interest herein may be assigned at any time by Michelin to an Affiliate.
- **20.3.** <u>Survival</u>. All obligations of the Parties pertaining to payment, reimbursement, indemnification, warranty, and any provision that is intended to come into or continue in force, and all obligations hereunder which by the terms of these General Terms and Conditions arise at or after termination, shall survive any termination or expiry of these General Terms and Conditions.
- **20.4.** <u>Severability</u>. If any Section or part of a Section of these General Terms and Conditions is declared illegal, null, or unenforceable, this illegality, nullity or unenforceability shall not affect the legality, validity, or enforceability of the other contractual clauses. The Parties shall negotiate in good faith to replace the invalid provisions with valid ones to achieve the intended commercial or business purpose of the illegal, null, or unenforceable provision.
- 20.5. Language and Notices. These General Terms and Conditions have been prepared in the language of the legal jurisdiction where the Michelin entity issuing the General Terms and Conditions is incorporated. All notices and other communications required or permitted under these General Terms and Conditions and any other contractual relationship between the Parties shall be in writing in the language of these General Terms and Conditions, a language mutually agreed by the Parties, or accompanied by a certified translation, all of such shall be valid, subject to their being sent to the addresses referred to in the introduction of these General Terms and Conditions (or to other addresses which the Parties shall have communicated to each other in written form), by courier, registered or express mail or mail under acknowledged receipt. In the event of a conflict between any notice in the language of these General Terms and Conditions and its accompanied certified translation, the version of the notice in the language of these General Terms and Conditions shall prevail. Any Party may change its address for such communications by giving appropriate written notice to the other Party conforming to this Section 20.5.



- 20.6. Right to Audit. Customer agrees to provide to Michelin, upon request, financial records, and other documentation reasonably necessary for MICHELIN to verify that Customer has performed its obligations hereunder. Such records and documentation will be kept by Customer for a minimum of five (5) years after expiration or termination of these General Terms and Conditions. Customer agrees that all such records and documentation will be made available to Michelin for audit upon seventy-two (72) hours' written notice from Michelin or its third-party auditor. Any on-site audit will be conducted during Customer's normal business hours. Michelin reserves the right to immediately withdraw all benefits under these General Terms and Conditions if Customer fails to provide supporting documentation to Michelin's satisfaction.
- **20.7.** Entire Agreement. These General Terms and Conditions and anything incorporated by reference herein constitute the entire agreement between the Parties and shall supersede all previous written documents or correspondence (if any) on the subject matter hereof.
- **20.8.** Execution/Counterparts. To the extent applicable, upon signature, these General Terms and Conditions may be executed in any number of counterparts, each of which shall be deemed an original but all of which taken together will constitute one and the same instrument. These General Terms and Conditions have been executed by the Parties' duly authorized representatives and electronic signature of these General Terms and Conditions made through the means of Electronic Transmission shall be as legally binding as a physical signature.
- **20.9.** Relationship of the Parties. These General Terms and Conditions apply to the sale of Michelin Products to Customer by Michelin and is not intended by either Party to constitute a franchise relationship between the Parties. Customer has not paid a franchise

- fee to Michelin and is not operating pursuant to a business system supplied by Michelin. Further, these General Terms and Conditions shall not be construed to create a joint venture, association, partnership, employment, or other force of business organization or agency relationship between Customer and Michelin.
- **20.10.** <u>Waiver.</u> Either Party's failure to enforce or exercise any of its rights under any provision of these General Terms and Conditions shall not be construed as a waiver of such rights. No custom, practice, or course of dealing constitutes a waiver of any provision of these General Terms and Conditions.
- **20.11.** <u>Amendments.</u> To the extent permitted by applicable mandatory law, Michelin reserves the right to modify these General Terms and Conditions at any time. The amended General Terms and Conditions are applicable from the moment they have first been made available regardless of the communication method. The applicable updated General Terms and Conditions are available on Michelin's website.
- **20.12.** <u>Conflicts.</u> If there is any conflict or ambiguity between any of the provisions of these General Terms and Conditions and subsequent Regional Terms Schedules, such conflict shall be resolved in accordance with the following order of precedence: Regional Terms Schedules and then these General Terms and Conditions.
- **20.13.** If there is any conflict or ambiguity between any of the provisions of these General Terms and Conditions and subsequent Regional Terms Schedules and any Customer documentation (such as Orders, general terms of purchase, etc.) these General Terms and Conditions and subsequent Regional Terms Schedules shall prevail.



REGIONAL TERMS | SWITZERLAND

These Regional Terms shall apply to Germany. In the event of a conflict between the MICHELIN Deutschland GmbH General Terms and Conditions of Sale for Replacement Sales (new tyres, retreading, services and purchase of carcasses) (GTCs) and these Regional Terms, these Regional Terms shall prevail.

Reference to a clause shall mean reference to a clause in the GTC unless otherwise specified.

1. PREAMBLE.

The Preamble shall be complemented by the following wording:

The GTC will be deemed to have been approved upon use (of any kind) of the carcass management service.

Supplementary, conflicting or differing terms and conditions imposed by Customer will not be deemed valid, even if Michelin does not expressly contradict them; they will only apply if and in so far as Michelin acknowledges them in writing on a case-by-case basis.

2. INTERPRETATION.

Definition of "Customers" in Section 1 (Definitions) shall be replaced by the following wording:

Customers: a dealer or large-scale commercial consumer currently engaged in a business relationship with Michelin.

Definition of "Products" in Section 1 (Definitions) shall be replaced by the following wording:

Products: all products distributed by Michelin, such as new tyres and retreaded tyres, and to any services performed. This includes:

- all goods offered (e.g. new tyres, retreaded tyres, accessories), and
- services (e.g. retreading).

3. PLACEMENT, ACCEPTANCE AND DELIVERY OF ORDERS.

 Section 2.2 (Acceptance) shall be complemented by the following wording:

Michelin will check and process Orders in respect of the type and quantity of the products being ordered when they are received by the Michelin Service Centre.

When Michelin confirms an order, no information contained in this order regarding price, terms and conditions, time of delivery or quantities to be delivered is confirmed.

 Section. 2.5 (Delivery) shall be complemented by the following wording:

Any undertaking to comply with the agreed delivery date in an individual case must be in writing in order to take effect and is subject to the provision that the manufacturing process and standard transport arrangements are not disrupted.

c) Section 2.6 shall be replaced by the following wording:

2.6 Unless otherwise stipulated or agreed on, deliveries are carriage paid to the Customer at Michelin's own risk (DAP Incoterms® 2020). The Customer will be responsible for unloading the delivery vehicles, and the vehicles must be unloaded on the agreed date. If no such date has been agreed, the Customer must unload the vehicle immediately. The Customer will bear any additional costs incurred in connection with expedited shipping on a case-by-case basis. No money will be reimbursed for collection by the Customer.

- d) Section 2.8 shall become the new Section 2.7 and shall complemented by the following wording:
 - In the exceptional event that Michelin agrees to the return of Products, the net cost price as originally calculated and invoiced will be credited. Also, Michelin reserves the right to invoice the costs which have occurred due to the return by applying an appropriate flat-rate.
- Section 2 will include a new Section 2.8 with the following wording:

Michelin provides Customers with significant yard business without significant resale business with the 3rd Party service (hereinafter "3P"). Through 3P, in the event of unavailability of selected new tyres, the Customer has the option of having them delivered by a selected Michelin resale partner or wholesaler (both hereinafter "Supplier"). Michelin reserves the right to limit order quantities and periods depending on availability.

The Supplier fulfils all legal requirements for an e-commerce business activity and guarantees Customer protection as well as data security and encryption. The appointment of Suppliers is at Michelin 's 's discretion.

If the new tyres are not available, the Customer can choose delivery by the Supplier during the ordering process by telephone, EDI or e-portal by pressing a button. The Customer thereby agrees to the transmission of his data stored at Michelin (name, company, delivery address and order data). Michelin then transmits this data directly to the Supplier. After transmission, the Customer will immediately receive a delivery status message via the system. The purchase contract is concluded between the Customer and Michelin.

4. TITLE AND RISK.

a) Section 3.1 shall be replaced by the following wording:

As principle, the risk will be transferred to the Customer upon handover.

If a debt collectible at the debtor's domicile has been agreed in the case of domestic delivery, the risk will be transferred to the Customer on the date on which the supplier makes available to the Customer for acceptance the object being supplied (EXW Incoterms ® 2020).

In cases where mail order sales have been agreed, the risk will be transferred to the Customer upon handover of the Products to the person assigned the task of performing the shipment (CIP Incoterms ® 2020). If shipment is delayed as a result of circumstances attributable to the Customer, the risk will be transferred to the Customer from the date on which the products are ready for shipment.

- b) Section 3.2 shall be replaced by the following wording:
 - 3.2.1 Michelin retains the title to all products delivered until all claims (including conditional and future claims) against the Customer arising from the business relationship have been settled. The same will apply if Michelin stands surety vis-à-vis third parties in connection with the business relationship.



Michelin is entitled to have the retention of title entered in the retention of title register at the Customer's place of business in accordance with Art. 715 ZGB up to this point in time. With its order, the Customer also gives its consent within the meaning of Art. 4 para. 4 of the Ordinance on the Registration of Retention of Title, so that Michelin can have the retention of title registered without any additional involvement of the Customer. If Michelin subsequently has to assert the retention of title against the Customer or third parties in or out of court in order to protect its rights, Michelin is entitled to charge the Customer for the costs of registering the retention of title.

- 3.2.2 In the event that Michelin enforces the retention of title, and irrespective of the Customer's payment obligation, Michelin is entitled to credit the products which have been taken back
 - at market price (= resale proceeds which can be achieved), or
 - ii) in accordance with 8.7. after deducting the value reduction.

In all such cases Michelin is entitled to deduct from the credit note the costs it has incurred in connection with taking the Products back, at a rate of 10 % of the amount credited. The Customer will remain at liberty to prove that the value was reduced by a lesser amount and that fewer costs were incurred in connection with taking the Products back.

- 3.2.3 In the event that the Products subject to retention of title are joined, mixed or combined with products not delivered by Michelin, and for the purpose of reducing the burden of proof, Michelin 's co-ownership share of the products in the Customer's possession pursuant to Sections 727 ZGB will be calculated by placing any of Michelin 's Products received within the six months before enforcement of Michelin 's rights to retention of title in proportion to the products delivered within the same period by a third party. This will not affect the Customer's right to provide evidence of a different co-ownership share.
- 3.2.4 The Customer must insure the Products subject to retention of title adequately, in particular against fire and theft. The customer hereby cedes insurance claims based on a loss involving the Products subject to retention of title to Michelin at replacement value. The Customer must inform the insurance company of the cession of claims. Michelin is entitled to notify the insurance company.
- 3.2.5 Until full settlement of all liabilities within the meaning of Ziffer 3.2.1., the Customer hereby cedes the claims against its customers arising on the basis of the resale of the Products subject to retention of title, in full and with all ancillary rights. The Customer will refrain from any actions which may jeopardise the agreed cession in advance, in particular agreements regarding the noncredibility of the claims to which the Customer is entitled on the basis of the resale and the inclusion of the claims in a current account relationship with its customers. If a current account relationship of this kind is nevertheless established, the current account claim will be deemed to have been ceded to Michelin in an amount corresponding to the claims included in the current

account relationship on the basis of resale of the products supplied by Michelin. The same will apply to the balance which appears in place of the current account claim after balancing.

- 3.2.6 In the event that the Products subject to retention of title are invoiced by the Customer together with other Products which do not belong to Michelin or together with services, it is hereby agreed that cession of the purchase price claim pursuant to 3.2.5. will take place at the amount charged by the Customer to its customer for the Products subject to retention of title, including VAT; if the individual price of Michelin 's Products subject to retention of title is not listed separately on the invoice, the cession will take place at the amount calculated by Michelin as the price charged by the Customer to its customer at the time of delivery.
 - If the Customer provides a service in connection with sale of the Products subject to retention of title, such as fitting, balancing or similar, and if the service and the Products subject to retention of title are not listed separately on the invoice, i.e. the value on the invoice is the overall price, the entire claim will be deemed to have been ceded to Michelin.
- 3.2.7 The Customer will only be entitled and authorised to resell or otherwise reuse the Products subject to retention of title under the provison that Customer transfers the aforesaid claims to Michelin and that Customer displays the name of the Michelin brand on the the invoice copies, delivery notes or other documents.
- 3.2.8 The Customer will be entitled to collect the claims arising on the basis of resale in spite of the cession. This will not affect Michelin 's right of collection. Michelin reserves the right to revoke the authorisation to collect claims if the requirements referred to in 3.2.10. and 3.2.11. are met.

 In the event of a substantial deterioration in the
 - Customer's financial situation as described in 2.7., the Customer's entitlement to resell the Products subject to retention of title and to collect any claims ceded to Michelin will expire. In such cases the Customer must allow Michelin 's agent to take any measures on the Customer's premises that Michelin deems appropriate and necessary to preserve and enforce its rights in connection with the retention of title.
- 3.2.9 In the event that the Customer wishes to sell or cede to a third party, on the basis of factoring or another form of debt purchasing (hereinafter "factoring"), amounts outstanding which relate in whole or in part to the sale of our Products, the Customer will be obliged to notify Michelin thereof in advance and to obtain Michelin 's consent.

Any claims to which the Customer is entitled vis-à-vis the factor on the basis of the factoring transaction must therefore be transferred to Michelin immediately in the amount of the relevant balance.

If Michelin has reason to believe that its claims or rights of security may be impaired or at risk, MICHELIN may at any time notify the factor of the rights of security arising under this section and request their settlement. If Customer sells or cedes the without Michelin 's



consent, the Customer must compensate Michelin for any associated damages.

If doubts exist regarding Michelin 's entitlement to compensation in cases of this kind, the Customer undertakes to instruct the factor to pay or deposit the sums to be paid out in the amount of Michelin 's balance into the custodian account stipulated by MICHELIN until the relevant circumstances have been clarified.

The above conditions apply both to genuine factoring (where the factor bears the credit risk) and non-genuine factoring (where the default risk remains with the seller of the claims).

- 3.2.10 The Customer must notify Michelin immediately of any attachment or other impairment of its rights of retention or rights of security by third parties and confirm these rights both to third parties and to Michelin in writing. The Customer is prohibited from any attachment of these rights and from any assignment or transfer of the security.
- 3.2.11 If the total value of our rights of security exceeds MICHELIN's total claims on a sustained basis by more than 20 %, MICHELIN will be obliged, upon request by the Customer and at its discretion, to release certain rights of security; the invoice value of the Products will apply with regard to Products subject to retention of title.
- 5. INTELLECTUAL PROPERTY AND CUSTOMER'S NON-DISPARAGEMENT OF PRODUCTS BEARING MICHELIN MARKS.

Section 5.1.10 shall not apply to these Regional Terms.

CUSTOMER'S ACCEPTANCE OR REJECTION OF PRODUCTS.

Section 6.1 shall be complemented by the following wording: Art. 201 OR applies to the customer's duty to inspect and give notice of defects. The Customer shall grant the driver access to the point of drop-off on request for the purpose of checking the drop-off quantity, providing that he has sufficient personal protective equipment and complies with the respective house rules.

7. PRICING, INVOICING AND TAXES.

a) Section 7.2 (Pricing) shall be complemented by the following wording:

If a price increase occurs during the period between the order date and the date on which the Products are delivered or the services provided, and if this period is shorter than four months, the Customer will be entitled to withdraw the order. Customer must notify Michelin of any such in writing as soon as the price increase is notified and before delivery of the Products or performance of the services.

8. PAYMENT.

- a) Section 8.1 shall be replaced by the following wording:

 Invoices and credit notes are due for payment within 15 days
 of the invoice date unless otherwise stated on the invoice or
 credit note or in the Commercial Program or in the contract. If
 the Customer is in default, all open claims will fall due for
 payment immediately, regardless of their due date.
- b) Section 8.3 shall be replaced by the following wording:

As a basic principle, Michelin reserves the right to accept cheques; Michelin will not accept post-dated cheques. Cheques will only be regarded as cash payments if they are credited within the payment deadlines. Cheques will only be credited if the full amount is duly received. Customer will be liable for any costs incurred, plus the relevant VAT. Michelin will not assume any liability for correct presentation and submission of protests.

- c) Section 8.5 shall be complemented by the following wording: Any objections by Customer to an invoice or to an invoice amount must be notified in writing to Michelin Suisse SA, Route Jo Siffert 36, Z.I. 3, Postfach 144, CH-1762 Givisiez (receipt of complaint). Customer may no longer lodge objections against the invoice after unconditional payment or expiry of the deadline without written notification.
- d) Section 8.7 shall be complemented by the following wording: Michelin reserves the right to withdraw credit previously granted, inter alia within the payment deadlines, in cases where Michelin has reason to believe that its claims or our rights of security are at risk. If Customer does not provide the surety promptly upon request, Michelin 's claim will fall due for payment immediately.
- e) Section 8.9. shall be complemented by the following wording: Customer will only be able to retain or offset payments on the basis of counterclaims which have been recognised by Michelin and which are undisputed, final and absolute and legally established.

Any right to payment or offsetting of turnover bonuses or other premiums and fee components will arise no earlier than six weeks after expiry of the relevant reference period. In particular, any such right will only arise when all claims which are due for payment have been settled by Customer.

f) Section 8 will be extended by a new Section 8.12:

In the event that payment by direct debit or SEPA direct debit has been agreed, the final amount shown on the invoice will be debited from Customer's bank account on the basis of the mandate issued within the framework of the direct debit or SEPA direct debit procedure. Customer hereby acknowledges that Michelin will issue notification of the amount and the date on which it will be debited no later than 5 working days before the relevant date. This will allow Customer to ensure that sufficient funds are available in the relevant account.

9. <u>LATE OR NON-PAYMENT; CHANGE IN FINANCIAL</u> STATUS.

Sections 9.1 – 9.4 shall be replaced by the following wording: As soon as the invoices are due, the customer shall be put in default by means of a reminder. If the Customer is in default, it shall pay default interest of 5 percentage points per annum on the gross final amount of the invoice due. Michelin's right to claim damages for default remains unaffected. In addition, the following costs shall be incurred in the dunning process: 1st reminder: CHF 5.00, 2nd reminder CHF 30.00. In the event of further default of payment, Michelin shall hand over the receivables to a collection agency commissioned by Michelin, which shall incur further processing costs in accordance with the guidelines of the Association of Collection Trustees at the expense of the Customer (https://inkassoverband.ch/wpcontent/uploads/2020/05/20200518-vsi-

GI%C3%A4ubigerschaden_extern.pdf)..



In the event of a payment default or if Michelin has other reasons to believe that its rights of retention are at risk, Michelin can enforce the rights of security referred to in Section 3 of the present Regional Terms. In such cases, the Customer is obliged to provide the information necessary for Michelin to enforce these rights and to hand over the necessary documentation, in particular delivery notes, invoices, inventory lists etc.

In the event of a payment default or if Michelin has other reason to believe that its rights of retention and its rights of security are at risk, Customer must notify its customers of the cession referred to in Section 3.2.5 of the present Regional Terms.

In the event that the Customer's financial situation deteriorates substantially, an affirmation in lieu of an oath has been given or a warrant issued to obtain the latter, the Customer experiences cash flow problems or (for example) the company changes owner as a result of cash flow problems, Michelin will be released from the obligation to fulfil any current Orders for delivery and entitled to halt all deliveries immediately unless the Customer agrees to step-by-step payment/cash-by-case payment. The same will also apply in the event that insolvency proceedings are initiated against the Customer, unless an agreement has been reached regarding ongoing deliveries of Products. In the event of default, Michelin is also entitled, among other things, to reclaim from the Customer at the Customer's expense the Products that have not yet been resold - with assignment of the purchase price claim to Michelin - or to demand that these Products be secured in a warehouse at the Customer's expense. In addition, Michelin is entitled to suspend any delivery to the Customer for the duration of the Customer's default in payment. Any claims of the Customer shall only become due after proper restitution.

10. TERMINATION

Sections 12 shall not apply to these Regional Terms.

11. PRODUCT WARRANTY AND RECALL.

- Section 14.2 shall be complemented by the following wording: Warranty claims will expire two years after delivery of the Products to the Customer.
- Section 14.3 shall be replaced by the following wording: Customer is entitled to assert warranty claims ("complaints") by telephone, via MyPortal and to the field service as follows:
 - i. All mandatory information about the claim must be complete and correct. This includes the assurance that the product in question was only driven with the vehicle specified in the claim.
 - The Customer shall name a dealer as the contact for processing the claim.
 - iii. After checking the details, Michelin shall decide whether to inspect the products. For this purpose, the products will be collected by Michelin or by a forwarding agent commissioned by Michelin after consultation with the dealer named for processing. Collection shall be at the risk and expense of the sender.
 - iv. For the purpose of a correct inspection, Michelin is authorised to cut or slice the claimed tyre. An inspected tyre becomes property of Michelin in the event of a credit note or other replacement.
 - v. If a claimed tyre is not inspected despite compensation
 as a gesture of goodwill and without recognition of a
 legal obligation it shall remain the property of the

product owner. As the owner of the tyre, he shall also be responsible for the proper disposal of the tyre.

Before asserting warranty claims, the Customer shall ensure and warrant that the owner of the product

- i. has agreed to the above information in accordance with Section 14.3.i.,
- ii. has agreed to the transfer of ownership to Michelin in the event of a credit note or other replacement.
- iii. has consented to the transfer of his personal data to Michelin and to the processing thereof for the purpose of handling the claim, and
- iv. has fully agreed to the present terms and conditions for the assertion of warranty claims pursuant to Section 14.3.
- Section 14.4 shall be replaced by the following wording: MICHELIN assumes warranty for the Products only under the following conditions.
 - 14.4.1 In the event that Michelin is liable for defects, Michelin will render subsequent performance, either through free elimination of the defects or redelivery, at its discretion.
 - 14.4.2 In cases where Michelin decides that defects can be duly eliminated through repairs, Michelin reserves the right to make the relevant repairs instead of delivering a replacement.
 - In the event of a failure to render subsequent performance or deliver a replacement, the Customer can request a reduction in the purchase price or withdraw from the contract; this will not affect the right to demand compensation in place of performance.
 - 14.4.3 By way of replacement for a tyre or inner tube affected by a significant defect, a tyre or inner tube will be delivered in exchange at the price valid on the date of the replacement delivery plus VAT. If the other party to the transaction is a business, Michelin reserves the right to offset an appropriate sum for benefit of use, taking into account the remaining tread depth. Any products replaced by means of a replacement delivery will be transferred into Michelin 's ownership.

All tyres will be delivered on the suspensory condition that the delivery contract in respect of the tyre will be annulled upon use of the tyre for the warranted purposes. When this condition is met, i.e. as soon as the dealer removes a replacement tyre from the warehouse in order to use it for the warranted purposes, the delivery contract in respect of this tyre will be cancelled. In individual cases where a warranty obligation has been rejected, the suspensory condition in respect of the tyre used in the relevant individual case will be deemed to have been inapplicable from the outset.

None of the size-related or technical information Michelin provides (e.g. dimensions) and none of the promotional statements should be deemed equivalent to a guarantee of warranted properties.

- 14.4.4 Warranty claims will be excluded and defects will not be deemed attributable to Michelin if:
 - . the tyre has been repaired, retreaded or otherwise worked on by parties other than Michelin.



- the damage is attributable to improper handling, tread modifications carried out improperly either in-house or by third parties, notches, etc., or an accident,
- iii. the tyre has not been inflated to the required air pressure or the air pressure prescribed by MICHELIN in the latest version of its technical documentation.
- iv. the tyre has been subject to excessive and irregular loads, e.g. the permitted load for each individual tyre size and the associated driving speed have been exceeded,
- v. the tyre has been damaged as a result of an incorrect wheel position or the tyre's performance has been impaired through other wheel arch faults (e.g. dynamic imbalance),
- vi. the damage to the tyre is attributable to rims which are not true to gauge, which are defective, or which are rusty, or the tyre has been placed on a rim other than that stipulated according to the relevant technical data,
- vii. the tyre has been damaged as a result of external impacts or mechanical damage, or has been exposed to excessive heat,
- viii. the factory number or the manufacturer's mark is no longer visible,
- ix. the reduction in value or suitability of the product is insignificant.
- 14.4.5 Michelin assumes warranty within the meaning referred to above in respect of tyre retreadings, tyre repairs and other subsequent tyre-related operations carried out by Michelin in so far as the liability relates to services which it has rendered. Michelin cannot assume any further warranty since the activities in question involve used materials.
- 14.4.6 The Customer must comply with Michelin 's recommendations in respect of storage, tyre choice, fitting, inflation, air pressure, use/restrictions on use, checks, repairs or similar and in respect of maintenance of the tyres. The Customer will notify his customers of our recommendations. If these customers are not end consumers, the Customer will pass on these information obligations to them.
- 14.4.7 The Customer hereby undertakes to ensure that all MICHELINRemix and LAURENT® retread tyres offered for sale are labelled as such; in particular, they must not be offered for sale as new tyres. The Customer also undertakes to provide its customers with an explanation of the exact characteristics and technical details of the Products.
- 14.4.8 Customer must provide its employees with training on how to handle Michelin products. The Customer must ensure that repairs (e.g. re-pairs of damaged tyres or welding procedures involving the wheel) are only carried out after removal of the wheel/tyre assembly.
- 14.4.9 Further details in this respect can be found in Michelin's technical documentation or on the Internet at www.michelin.de and www.lkw.michelin.de.
- 14.4.10 When handing the product over to an end customer, the Customer will be obliged to observe the technical

guidelines and operating instructions, to provide its customers with information regarding these guidelines and instructions and to impose an obligation to ensure that this information reaches the end customer.

12. LIMITATION OF LIABILITY.

Section 15 shall be replaced by the following wording:

A claim for damages by the Customer is excluded, irrespective of the grounds for liability (e.g. non-performance, impossibility, delay, positive breach of contract and breach of obligations in contract negotiations, tort, settlement between debtors, etc.), unless the liability is based on unlawful intent or gross negligence on the part of Michelin or one of Michelin's legal representatives or vicarious agents. Liability towards the injured party in accordance with the Product Liability Act (PrHG) remains reserved.

These liability regulations also apply to the personal liability of Michelin's legal representatives and employees and other vicarious agents.

13. USE OF CUSTOMER DATA AND DATA PROTECTION.

Section 17.2.5. shall be complemented by the following wording:

Data subjects seeking to exercise their rights shall contact

14. <u>GOVERNING LAW, JURISDICTION, AND DISPUTE</u> RESOLUTION.

- a) Section 19.1 shall be deleted and replaced as follows: Swiss law shall apply exclusively.
- b) Section 19.4 shall be deleted and replaced as follows: Without prejudice to clause 19.3, the place of jurisdiction for all disputes shall be Fribourg (subject to any appeal to the Federal Supreme Court).

15. MISCELLANEOUS TERMS.

 Section 20.5. (Language and Notices.) shall be replaced by the following wording:

These General Terms and Conditions have been prepared in German language as well as in English language. In the event of ambiguity or contradictions between the different versions of the General Terms and Conditions of Business (German and English), the original German text will apply.

 b) Section 20.7. (Entire Agreement) shall not apply to these Regional Terms.

16. RETREADING.

A new Section 21 (Retreading) shall be added to the GTCs: A distinction is made between the following retreading procedures:

21.1 Customer-owned (Nomi / custom retreading): The Customer sends in a retreadable carcass for retreading and selects one of the retreading options in the currently available CB list (calculation basis). The products and brands which can be selected depend on the dimension and tread of the carcass which has been sent in. The Customer can contact the Michelin Service Centre to obtain copies of the latest documentation regarding the



retreading programme. Once the retreading procedure has been completed using the carcass that was sent in, the retreaded tyre will be returned to the Customer.

- 21.2 Carcass bank: The Customer opens a "carcass bank account", deposits carcasses in the account and then withdraws them whenever necessary as retreaded tyres. The Customer must conclude a separate agreement with Michelin in order to open the account and process deposits and withdrawals.
- 21.3 Exchange: The Customer sends in a retreadable carcass for retreading and orders a retreaded tyre in return. The Customer receives the retreaded tyre once checks have been carried out on the tyre which has been sent in to confirm its suitability. The Customer selects the tread of the retreaded tyre on the basis of the current CB list, taking into account the dimension and tread of the carcass which has been sent in. The products and brands which can be selected depend on the dimension and tread of the carcass which has been sent in. The Customer can contact the Michelin Service Centre to obtain copies of the latest documentation regarding the retreading programme.
- 21.4 Retreading, carcass included: Michelin offers the Customer, depending on availability, a retreaded tyre, including the carcass, on the basis of the current CB list. MICHELIN reserves the right to change the current retread offer including carcass according to the KB list at any time.
- 21.5 Carcass purchases: The dealer offers Michelin retreadable Michelin original carcasses with a maximum DOT of 10 years (Michelin will inform the dealer of any exceptions on a case-by-case basis) at the prices and under the terms and conditions stipulated in the respectively valid Michelin purchase price lists. In the event that the shipment or recovery of the carcasses cannot be carried out as planned or the shipment or recovery is carried out as an unlawful shipment, Michelin and the dealer hereby undertake to accept the carcasses back or to ensure that they are otherwise recovered, and to arrange for their storage in the interim period if necessary.

After Michelin has accepted an order, the carcasses will be collected from the Customer or from the dealer by Michelin or by a freight forwarder acting on its instructions. Upon collection, the carcasses must be free of oil, grease, water or other heavy soiling, and any foreign bodies must have been removed. The tyre number, DOT code and Emark (type approval number) must be present and legible.

Michelin will be responsible for the loading of delivery vehicles. Michelin will bear the costs and risks of transport. Upon collection from the Customer, from the dealer or from the dealer's customer, ownership of the carcasses will be transferred to Michelin. In cases where the Customer or dealer is not the owner of the carcasses, the Customer or dealer must ensure that the owner has agreed to the transfer of ownership to Michelin upon collection of the carcasses.

Michelin checks all carcasses when they arrive at its premises. Carcasses which are checked upon arrival at Michelin premises and classified as "not suitable for retreading" or which are destroyed during retreading as a direct result of their characteristics will be disposed of

immediately via the appropriate channels. MICHELIN will be responsible for selecting an appropriate disposal channel which complies with the applicable legislation. The Customer or dealer will be liable for any costs incurred by MICHELIN in connection with checking the suitability of the carcass and transporting it, and in connection with its disposal (which generally attracts a charge); a flat-rate fee according to the current price list will be charged to cover these costs. In the event that a carcass is destroyed during factory retreading for reasons not attributable to the carcass's characteristics, the Customer will receive a replacement carcass of Michelin 's choice. A description of the damage will be available to the Customer or dealer via the online portal Michelin e-Remix.

21.6 Carcass sales: Michelin offers Customers retreadable carcasses on the basis of a separate agreement and subject to availability. Non-retreadable carcasses must be disposed of directly by the Customer via appropriate disposal channels. In the event that the shipment or recovery of the carcasses cannot be carried out as planned or the shipment or recovery is carried out as an unlawful shipment, Michelin and the Customer hereby undertake to accept the carcasses back or to ensure that they are otherwise recovered, and to arrange for their storage in the interim period if necessary.

17. ELECTRONIC DATA INTERCHANGE.

A new Section 22 (Electronic Data Interchange) shall be added to the GTCs:

Michelin is entitled to offer the Customer the option of handling payments using electronic data interchange (EDI) procedures instead of paper-based procedures within the framework of Michelin 's e-business portfolio. This will involve the production and forwarding of electronic invoices and electronic credit notes (hereinafter "e-invoices"). Any such e-invoices will replace the original invoices/credit notes previously issued as hard copies and will meet the statutory requirements which apply to e-invoices, in particular the EU Invoice Directive 2021/45/EU and VAT Act.

Provided that the original invoices and/or credit notes have been created and forwarded as hard copies, the Customer will be notified in writing about the relevant particulars before the changeover takes place (e.g. administrative details, implementation timeframes, third parties involved, storage location).

The Customer hereby consents to the forwarding of e-invoices by Michelin or third parties acting on Michelin's instructions and the associated terms and conditions, and will take the necessary technical measures to ensure that the e-invoices can be accessed as agreed.
